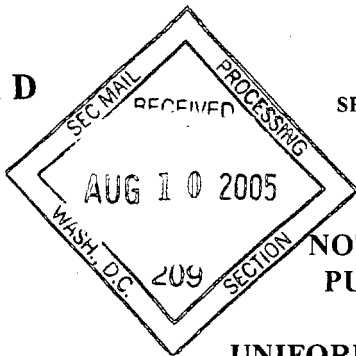





Some of these fees may be paid by the General Partner and not by the Issuer.

Sales Commissions

No commissions will be paid from the proceeds of the offering.

Salaries and Fees
