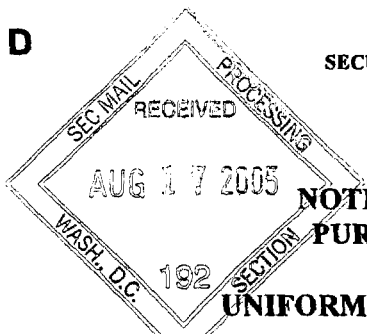

Ventana Canyon Alliance, LLC was formed for the purpose of acquiring, owning and operating (i) Ventana Canyon Golf and Racquet Club, which includes a golf, tennis and social membership country club consisting of two eighteen hole golf courses, a multi-court tennis facility, pro-shops and related amenities, (ii) The Lodge at Ventana Canyon consisting of a 50 room resort lodging facility, and (iii) approximately 5.6 acres of vacant land plated as The Clubdominiums at Ventana Canyon Golf and Racquet Club, Units 52 through 111.


