

Spring Star Development, L.L.C. is an entity which has been formed to construct, own and operate a hotel in Paola, Kansas. Investors who acquired membership interests in the Company will participate in the profits of the Company and in accordance with the Company's Operating Agreement.

Financing for the hotel has been negotiated through dealings with the City of Paola and will largely be financed through industrial revenue bonds. In order to receive the full benefit of the bonding process, the money raised from investors in Spring Star Development, L.L.C. will be used to purchase a Series B industrial revenue bond issued by the City. The proceeds of that bond will go toward development of the hotel property under lease with the City.
