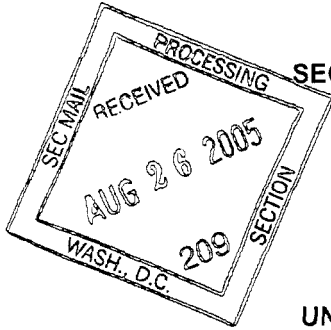

## EXHIBIT A

Logos Multi-Strategy Hedge Fund I, LP (“Partnership”) is a limited partnership organized for the purpose of investing and trading in a wide variety of securities and financial instruments, domestic and foreign, of all kinds and descriptions, whether publicly traded or privately placed, including but not limited to common and preferred stocks, bonds and other debt securities, convertible securities, limited partnership interests, mutual fund shares, options, warrants, commodities, futures, derivatives (including swaps, forward contracts and structured instruments), currencies, monetary instruments and cash and cash equivalents. Generally, new Limited Partners will be admitted on the first day of each month. Although there is no maximum or minimum aggregate amount of limited partnership interests which may be sold in this continuous offering, we have inserted the figure of \$100,000,000 in Part C(1) of Form D as a reasonable estimate of the aggregate offering price of such limited partnership interests.
