

The interests will be continuously offered in the sole discretion of the general partner of the Partnership. Although there is no maximum or minimum aggregate amount of limited partnership interests which may be sold in this continuous offering, we have inserted the figure of \$100,000,000 in Part C(1) of Form D as a reasonable estimate of the aggregate offering price of such limited partnership interests.
