



## EXHIBIT A

Spencer Capital Opportunity Fund, LP (“Partnership”) is a limited partnership organized to invest and trade in securities and financial instruments of all kinds, domestic and foreign, whether publicly traded or privately placed, including but not limited to common and preferred stocks, bonds and other debt securities, convertible securities, limited partnership interests, mutual fund shares, options, warrants, commodities, futures, derivatives (including swaps, forward contracts and structured instruments), currencies, monetary instruments and cash and cash equivalents. The Interests will be continuously offered in the sole discretion of the General Partner. Although there is no maximum or minimum aggregate amount of Interests which may be sold in this continuous offering, we have inserted the figure of \$100,000,000 in Part C(1) of Form D as a reasonable estimate of the aggregate offering price of such Interests.
