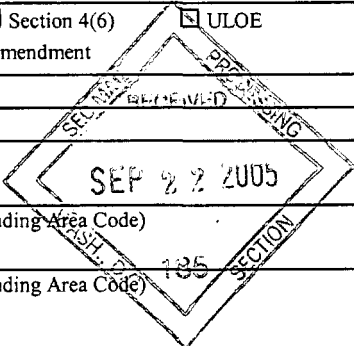



ATTACHMENT TO FORM D

On September 12, 2005, Emergent Respiratory Products, Inc. ("*Emergent*") issued Secured Convertible Promissory Notes (the "*Notes*") to certain investors in the aggregate principal amount of \$813,952.44 pursuant to a Secured Convertible Promissory Note and Warrant Purchase Agreement (the "*Agreement*"). Under the terms of the Agreement, Emergent agreed to issue to each initial investor warrants in connection with the Notes and allocated a purchase price of \$1.00 per warrant. Each of the three initial investors received two warrants each for an aggregate purchase price of \$6.00. The \$6.00 is reflected in Section C, 1 of the Form D, under the column entitled "Amount Already Sold," bringing the debt amount from \$813,952.44 to \$813,958.44.
