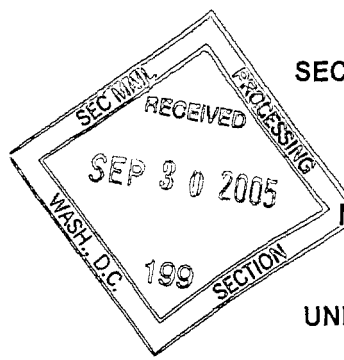





## EXHIBIT A

Apis Global Deep Value Fund, Ltd. ("Fund") is a Cayman Islands exempted company formed to pool investment funds of investors for the purpose of investing and trading in wide variety of securities and financial instruments, domestic and foreign, of all kinds and descriptions, whether publicly traded or privately placed, including but not limited to common and preferred stocks, bonds and other debt securities, convertible securities, limited partnership interests, mutual fund shares, options, warrants, commodities, futures, derivatives (including swaps, forward contracts and structured instruments), currencies, monetary instruments and cash and cash equivalents. The Fund is offering the shares (the "Shares") to persons and entities outside of the United States that are not U.S. Persons and to a limited number of U.S. Persons that are generally exempt from U.S. Federal income taxation, and who meet other suitability requirements. Although there is no maximum or minimum aggregate amount of Shares which may be sold in this continuous offering, we have inserted the figure of \$100,000,000 in Part C(1) of Form D as a reasonable estimate of the aggregate offering price of such Shares.
