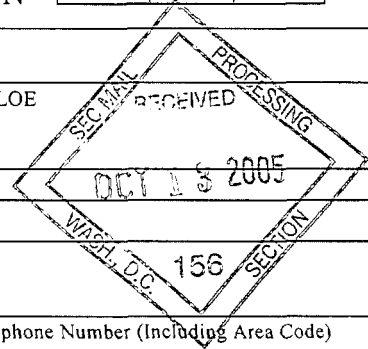

** The issuance of Series A and Series B Preferred Units of Holdings was part of a larger recapitalization of Holdings. In lieu of receiving Series B Units holders of Class C Common Units of Mortgagebot LLC could elect to receive cash. The expenses of the recapitalization were paid out of these cash proceeds.
