

**The issuer will pay the General Partner a Management Fee equal to 2% per annum of the total Capital Contributions until the end of the Primary Investment Period (earlier of 2 years and the General Partner's determination to end the period) and 1% per annum thereafter, in all cases reduced by 50% of the amount of qualifying fee income. 
