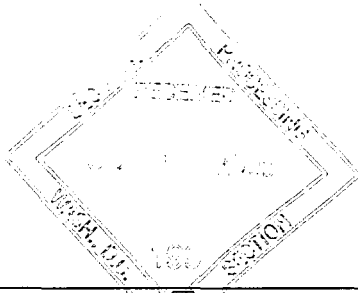





EXHIBIT A

CE Equity – Very Small Cap US Long LP (“Partnership”) is organized for the purpose of providing qualified investors an effective vehicle for participation in attractive investment opportunities provided by selected very-small cap publicly traded US stocks. The Partnership will invest and trade in publicly traded common and preferred stocks of selected US companies, in cash, cash equivalents and other short-term debt instruments, and, from time to time, in selected hedging activities. The interests will be continuously offered in the sole discretion of the General Partner. Although there is no maximum or minimum aggregate amount of limited partnership interests which may be sold in this continuous offering, we have inserted the figure of \$100,000,000 in Part C(1) of Form D as a reasonable estimate of the aggregate offering price of such limited partnership interests.
