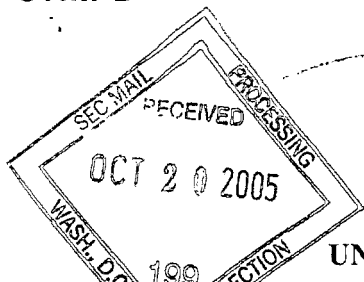



AMOUNT OF PURCHASES

The amount "purchased" under the 2006 Nonqualified Deferred Compensation Plan (the "2006 Plan") cannot be determined at this time.

Therefore, the amount of compensation to be deferred under the 2006 Plan cannot be determined until the end of the plan year.
