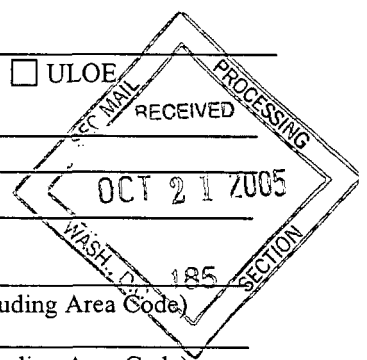

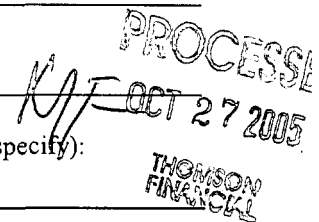



² As set forth in the Partnership Agreement, the Partnership will pay its own operating and organizational expenses (or reimburse the General Partner to the extent incurred by the General Partner). In addition, the Partnership will pay the General Partner a fixed fee computed at an annual rate of 1.5% of the aggregate value of the capital accounts of the Limited Partners. This fixed fee will be paid quarterly and will be calculated based on the value of the Capital Accounts of the Limited Partners at the beginning of a fiscal quarter. The General Partner will also receive a performance allocation equal to 20% of the net profits allocated to each Limited Partner's Capital Account at the end of each fiscal year. However, no performance allocation will be made in respect of a fiscal year until any net loss previously allocated to the Capital Account of a Limited Partner has been offset by subsequent net profits allocated to the Capital Account of each Limited Partner. Such expenses, fixed fee and performance allocation cannot be quantified at present.
