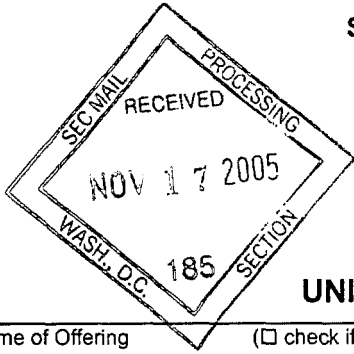



* It is anticipated that the General Partner or associates of the General Partner will act as the management company of the Issuer (the "Management Company"). The Management Company will receive an annual fee equal to 2.5% of the funds committed to the Issuer, which fee will be reduced after the fifth anniversary of the final closing of sale of partnership interests by the Issuer to 2% of all amounts invested in portfolio companies plus the amount of reserves for follow-on investments (but in no event will be less than \$300,000 (the "Management Fee")).
