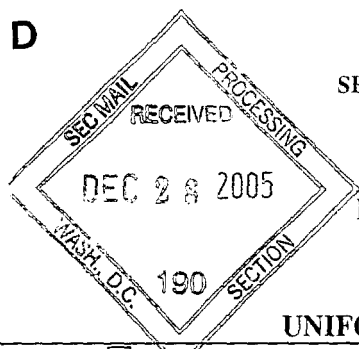



The Issuer has sold 2,564,437 of its Units (the "Shares"), each Unit consisting of one common share ("Share") and one warrant ("Warrant"), at an average price of \$0.68376068376 USD (\$0.80 CAD) per Share for total proceeds of \$1,753,461.20 USD (\$2,051,549.60CAD).

Of the Shares sold, 485,687 Units were sold into the United States for proceeds of \$332,093.68 USD.

The offering was effected in the United States pursuant to Regulation D and outside the United States pursuant to Regulation S.
