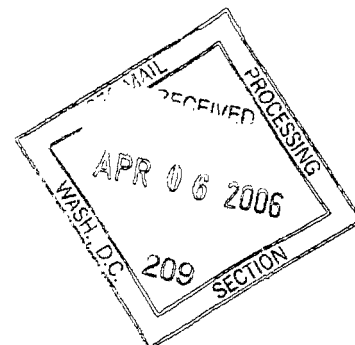

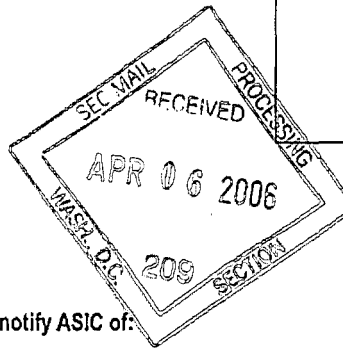
**CANCELLATION OF SHARES
