## **EXHIBIT A**

Central American & Caribbean Real Estate US Fund I-B, LP ("Partnership") is a limited partnership organized for the purpose of investing in real estate opportunities in the Central American and Caribbean region. The Partnership's minimum investment amount is \$250,000 for individuals and \$5,000,000 for entities, although the general partner, Southern Bridge Capital Partners (the "General Partner"), has discretion to accept lesser amounts (but in no event less than \$100,000 for individuals). The interests will be offered in the sole discretion of the General Partner. The maximum aggregate amount of limited partnership interests which may be sold in this offering is \$150,000,000, and we have inserted this figure in Part C(1) of Form D as a reasonable estimate of the aggregate offering price of such limited partnership interests.
