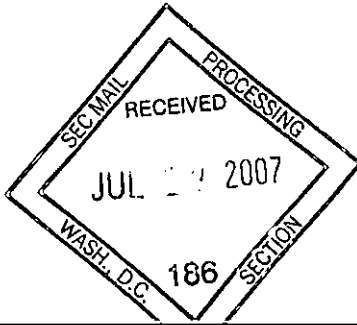

## EXHIBIT A

FVP Overseas, Ltd. ("Fund") is a Cayman Islands exempted company that was organized for the purpose of investing and trading in a wide variety of securities, financial instruments and other assets and investments, domestic and foreign, of all kinds and descriptions, whether publicly traded or privately placed, including, without limitation, privately issued and publicly traded common stocks, privately negotiated equity and equity-related investments in publicly traded and privately held companies, exchange-traded funds, preferred stock, stock warrants, options and rights, bonds, debentures, convertible securities and money market obligations. The Fund's minimum investment amount is \$1,000,000, although Firefly Value Partners, LP ("Investment Manager") has discretion to accept lesser amounts. The shares of stock will be offered in the sole discretion of the Investment Manager. Although there is no maximum or *minimum* aggregate amount of the shares of stock which may be sold in this continuous offering, we have inserted the figure of \$200,000,000 in Part C(1) of Form D as a reasonable estimate of the aggregate offering price of such shares of stock.
