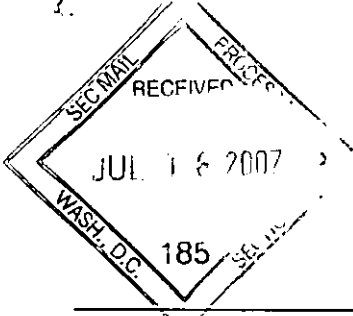



¹ In exchange for the extinguishment of \$7,500,000 of outstanding obligations under that certain Credit Agreement, dated March 3, 2006, among Goodman Networks Incorporated ("Goodman"), certain of Goodman's subsidiaries and the lenders party thereto, Goodman issued 7,500 shares of Series A Senior Convertible Preferred Stock. The offering also consisted of 700 shares of Series B Senior Convertible Preferred Stock being offered to management in exchange for \$700,000 cash.
