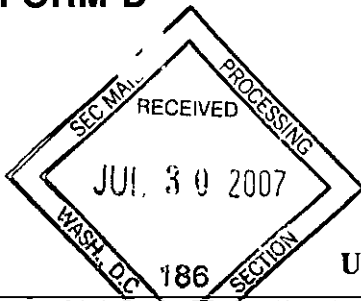



**DATED JUNE 1, 2007 - \$5,000,000 JOINT ISSUANCE OF DEBT**

The Offering is a joint issuance of debt by four separate operating corporations, namely: **TMS Group, Inc.**, an Alabama corporation; **Payday Now, Inc.**, an Alabama corporation; **Express Check Services, Inc.**, a Delaware corporation; and **Three Rivers Investment, Inc.**, a Delaware corporation (individually or collectively referred to in the Offering Memorandum as the "Company"), doing business under various trade names, including "The Money Store" and "The Money Zone". Each of the corporations is a joint maker/obligor of the Notes issued with regard to the debt. The aggregate offering price of the jointly issued Notes is \$5,000,000.00. Each corporation is filing with the U.S. Securities and Exchange Commission, and, as applicable, the state administrators for any state in which a notice filing is required, a separate Form D Notice of Sale of Securities Pursuant to Regulation D. Each filing reflects the aggregate offering price of the debt securities as \$5,000,000.00.
