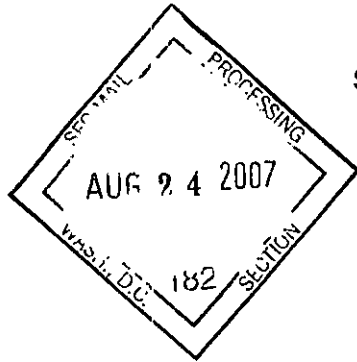



## EXHIBIT A

GMB Global Alpha Offshore, Ltd. ("Fund") is Cayman Islands exempted company that was organized for the purpose of investing and trading in a wide variety of investments, domestic and foreign, of all kinds and descriptions, whether publicly traded or privately placed, including but not limited to common and preferred stocks, bonds and other debt securities, convertible securities, limited partnership interests, mutual fund shares, options, warrants, futures, derivatives (including swaps, forward contracts and structured instruments), monetary instruments, other financial instruments, real estate, private businesses, cash and cash equivalents. The Fund's minimum investment amount is \$1,000,000, although the Board of Directors of the Fund has discretion to accept lesser amounts. The shares of stock will be offered in the sole discretion of the Board of Directors of the Fund. Although there is no maximum or minimum aggregate amount of the shares of stock which may be sold in this continuous offering, we have inserted the figure of \$200,000,000 in Part C(1) of Form D as a reasonable estimate of the aggregate offering price of such shares of stock.
