EXHIBIT A

Amberjack Capital Management, LP ("Partnership") is a limited partnership that was organized for the purpose of investing and trading in a wide variety of securities and financial instruments, domestic and foreign, of all kinds and descriptions, whether publicly traded or privately placed. The Partnership intends to focus primarily on equity securities, short sales, options purchases and writing, foreign securities and private placements. The Partnership's minimum investment amount is \$100,000, although SWC Partners, LLC, the general partner of the Partnership ("General Partner") has discretion to accept lesser amounts. The limited partnership interests will be offered in the sole discretion of the General Partner. Although there is no maximum or minimum aggregate amount of the limited partnership interests which may be sold in this continuous offering, we have inserted the figure of \$200,000,000 in Part C(1) of Form D as an estimate.
