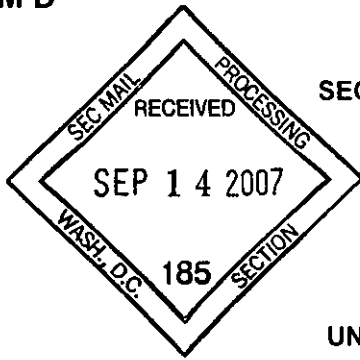





EXHIBIT A

PWG Prime, LP ("Partnership") is a limited partnership that was organized for the purpose of investing and trading in a wide variety of securities, commodities and other financial instruments, domestic and foreign, of all kinds and descriptions, whether publicly traded or privately placed, including but not limited to common and preferred stocks, bonds and other debt securities, convertible securities, asset-backed securities, limited partnership or limited liability company interests, mutual fund shares, closed-end investment funds, options, warrants, commodities, futures contracts, currencies (including forward contracts thereon), precious metals, derivative products of all types (including interest rate and currency derivatives, forward contracts and structured/indexed securities), monetary instruments and cash and cash equivalents. The Partnership's minimum investment amount is \$1,000,000, although PWG Partners, LLC ("General Partner") has discretion to accept lesser amounts. The limited partnership interests will be offered in the sole discretion of the General Partner. Although there is no maximum or minimum aggregate amount of the limited partnership interests which may be sold in this continuous offering, we have inserted the figure of \$200,000,000 in Part C(1) of Form D as a reasonable estimate of the aggregate offering price of such limited partnership interests.
