



## EXHIBIT A

Fortelus Special Situations Fund LP ("Partnership") is a limited partnership that will generally invest all of its assets (to the extent not retained in cash) in the ordinary shares of Fortelus Special Situations Master Fund Ltd., a Cayman Islands exempted company (the "Master Fund"). The principal investment objective of the Master Fund will be to achieve superior risk-adjusted total returns by investing primarily in European public and private non-investment grade and non-rated debt instruments, distressed businesses, and special situation equities and equity-related instruments in which the true value of the business may be obscured by external factors. The Partnership's minimum investment amount is €2,000,000, although Fortelus GP Ltd. ("General Partner") has discretion to accept lesser amounts. The limited partnership interests will be offered in the sole discretion of the General Partner. Although there is no maximum or minimum aggregate amount of the limited partnership interests which may be sold in this continuous offering, we have inserted the figure of \$500,000,000 in Part C(1) of Form D as a reasonable estimate of the aggregate offering price of such limited partnership interests.
