

EXHIBIT A

AlphaBet Partners, LP ("Partnership") is a limited partnership that was organized for the purpose of investing and trading in a wide variety of securities and financial instruments, domestic and foreign, including, but not limited to common and preferred stocks, bonds and other debt securities, convertible securities, limited partnership interests, mutual fund shares, options and warrants. The Partnership's minimum investment amount is \$1,000,000, although AlphaBet Advisors, LLC, the general partner of the Partnership ("General Partner") has discretion to accept lesser amounts. The limited partnership interests will be offered in the sole discretion of the General Partner. Although there is no maximum or minimum aggregate amount of the limited partnership interests which may be sold in this continuous offering, we have inserted the figure of \$200,000,000 in Part C(1) of Form D as an estimate.
