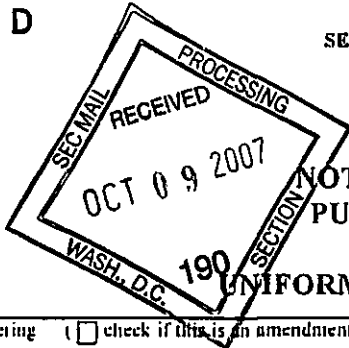

In addition, an aggregate amount not exceeding approximately \$9,750,000 in restricted stock grants are being made to various accredited investors who are directors, officers, and/or key employees of the issuer and/or one or more of its direct or indirect subsidiaries.
