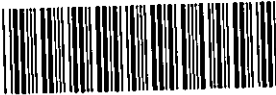



\* On October 31, 2006, the Board of Directors of the Company authorized the sale and issuance of up to 2,600,000 shares of Series A Preferred stock (the "Stock") at a purchase price of \$1.00 per share. The offer was not subject to the subscription and purchase of any minimum number of shares. The Stock was initially offered to the shareholders of the Company owning 50,000 or more shares of Series A Preferred Stock, and 500,000 shares of the Stock were purchased pursuant to the offer. On January 5, 2007, the Company previously transmitted to both the Securities and Exchange Commission and the Securities Compliance Branch, Department of Commerce and Consumer Affairs, State of Hawaii, for filing, a Form D Notice of Sale of Securities Pursuant to Regulation D, Section 4(6), And/OR Uniform Limited Offering Exemption, regarding the offer and the initial purchase of shares pursuant thereto. The Board of Directors subsequently extended the offer and an additional 369,262 shares were purchased pursuant to the offer as extended. This Form D is filed as a precautionary matter to supplement and update the Form D previously transmitted for filing on January 5, 2007, in order to reflect, to the extent necessary or appropriate, the sale of additional securities pursuant to the offer as extended.


