(1) On December 11, 2007, the Company issued (i) a secured convertible promissory note of up to \$5 million to be funded in two tranches, \$1 million funded on December 11, 2007 and the remainder scheduled on or about January 3, 2008, and (ii) a warrant to purchase up to 3,400,000 common shares at an exercise price of \$0.01 per share. The warrant is exercisable with respect to only 680,000 common shares until the second tranche of the note is funded and until and unless shareholder approval has been received, the exercise of the warrant, and the conversion of the note combined, is limited to only 19.9% of the Company's common shares. 
