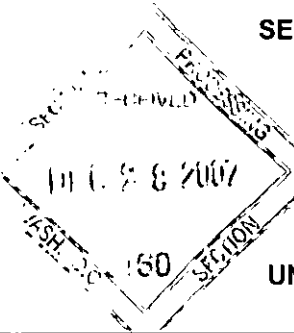



EXHIBIT A

Wexford High Yield Debt Offshore Fund, Ltd. ("Fund") is a Cayman Islands exempted company that its investment objective is to preserve principal while delivering superior risk-adjusted returns with low correlation to the equity markets by making high yield short-term opportunity loans secured by first or second mortgages on primarily commercial and multi-family real estate assets. The Fund's minimum investment amount is \$500,000, although the Board of Directors have discretion to accept lesser amounts. The shares of stock will be offered in the sole discretion of the Board of Directors. Although there is no maximum or minimum aggregate amount of the shares of stock which may be sold in this continuous offering, we have inserted the figure of \$200,000,000 in Part C(1) of Form D as a reasonable estimate of the aggregate offering price of such shares of stock.
