## EXHIBIT A

Robertson Capital Partners I, L.P. ("Partnership") is a limited partnership organized to buy and sell securities of micro to large capitalized companies, including stocks, warrants, rights, options, and debt securities of U.S. and non-U.S. entities. The Partnership may invest and trade in public and private securities and may lend funds or assets and borrow money, with and without collateral. The Partnership's minimum investment amount is \$50,000, although Robertson Capital Management, LLC ("General Partner") has discretion to accept lesser amounts. The limited partnership interests will be offered in the sole discretion of the General Partner. Although there is no maximum or minimum aggregate amount of the limited partnership interests which may be sold in this continuous offering, we have inserted the figure of \$200,000,000 in Part C(1) of Form D as a reasonable estimate of the aggregate offering price of such limited partnership interests.
