## Samsung Electronics' Pre-Earnings Guidance

**On April 6, 2010, Samsung Electronics disclosed its '10. 1Q consolidated earnings estimate as follows.**

- Sales: Approximately 34 trillion Won
- Operating profit: Approximately 4.3 trillion Won

The above estimate is provided for the convenience of investors, before the earnings results are finalized. Domestic disclosure regulations do not allow earnings estimates to be given in a range. Therefore, the above figures are the median of the earnings estimate range given below.

- Sales: 33 ~ 35 trillion Won
- Operating profit: 4.1 ~ 4.5 trillion Won

※ The above figures are consolidated earnings estimates based on K-IFRS.

※ Re-stated '09 1Q and 4Q, and '09 annual consolidated figures based on K-IFRS are as follows:
