• Increase in inquiries regarding self-directed accounts

- Common issues:
 - Increased trading activity under premise of "free" trading
 - Inadequate and inconsistent customer support
 - Outages with platform or app

Novice Investors

- Informal survey of our peers ages 24 to 32 showed:
 - Gamification made investing easier
 - Lack of investment experience
 - FOMO
 - Addictive nature
 - Layout, color, and design of application prompted an action

Additional Concerns with Gamification

- Referral systems
- Trending lists
- Lack of user mindfulness while using these applications
- Terms and conditions (recurring investments)

Examples of Referral Systems


