## Dear Mr. Mansueto and Mr. Kapoor:

We the undersigned represent a broad range of organizations from across the United States with a long history of combating delegitimization of Israel, including the Boycott, Divestment and Sanctions (BDS) campaign founded in the denial of the right of Israel to exist as a sovereign nation. We appreciate Morningstar's decision to retain and make public the White & Case (W&C) law firm's report that examined anti-Israel bias in its Sustainalytics subsidiary's Environmental, Social, and Governance (ESG) products and practices. At a time in which ESG reporting and products are receiving investor, legislative and regulatory scrutiny, it is important to demonstrate accountability and provide transparency to all constituencies.

While we commend you for pledging to terminate Sustainalytics' Human Rights Radar (HRR) product, ending the bespoke research that W&C flags as likely to produce biased results, and transparently implementing some of the other recommendations, the report makes clear that built-in bias against Israel² infects Sustainalytics' methodology and sources, and thus, its other ESG ratings products. This bias is not only unfair and harmful to Israeli companies and those doing business in and with Israel, but such bias also threatens to tarnish the ESG ratings framework itself. As a leading financial ratings company that seeks to provide its customers with research free of bias, Morningstar should take the opportunity to cleanse its products of all anti-Israel bias and set an example of fairness and reliability for all companies providing ESG ratings, which represent one-third of dollars managed globally.³

In your open letter addressing Sustainalytics' biases in rating companies doing business in Israel,<sup>4</sup> you claim that neither Morningstar nor Sustainalytics supports BDS.<sup>5</sup> While opposition to BDS is an important statement to make, the W&C report revealed that Sustainalytics' methodology and choice of sources routinely resulted in biased ratings of Israel-related companies, facilitating the boycott and divestment at the heart of the BDS campaign. This is of serious concern not only to the Jewish community, but to millions of people who reject anti-Israel bias as well as to companies doing business with Israel.

In the spirit of supporting your goal of removing unacceptable bias from all your company's products and engendering the "trust [that] investors place in the data, research, and analytics [you] provide," we urge you to take additional measures to comprehensively address and eliminate anti-Israel bias in all Sustainalytics' products and practices, including by making broader changes in some of the areas where W&C's recommendations make only partial progress.

Specifically, we urge you to implement the following steps:

1. Engage with persons with deep knowledge of Israeli and Jewish history and politics (such as the signatories to this letter who understand efforts to undermine Israel) to examine and eliminate sources with a history of anti-Israel activities and/or those that have been denounced by the U.S. Government and other credible stakeholders. The W&C report made clear that Sustainalytics has used and continues to use sources with known biases against Israel. It recommends removal of some biased sources, including those that had been "inadvertently" left in after a previous review. The fact that biased sources like Electronic Intifada were used until recently, however, demonstrates the depth of the problem. Continuing reliance on known biased sources for an assessment of reputational risk does a disservice to the investors which rely on Sustainalytics. Such sources include: the United Nations Human Rights Council (UNHRC), whose vocal members include notorious human rights violators such as Cuba, Sudan, and Venezuela, and which has a long and infamous history of unfairly singling out Israel for criticism and condemnation; Amnesty International, an organization roundly criticized for libeling Israel an "apartheid" state; and Who Profits, an NGO dedicated to targeting commercial involvement

with Israel and promoting BDS activities.<sup>12</sup> While the W&C report states that sources such as UNHRC are not dispositive, heavy reliance on anti-Israel sources predisposes Sustainalytics' review and necessarily compromises the integrity of Sustainalytics' ESG system.

- 2. Rather than undertaking only smaller process changes<sup>13</sup>, address the inherent flaws in the existing methodology of reputational reporting on Israel that produces the structural bias.

  The report does not conclude that *only* the Human Rights Radar has indicia of bias; indeed, W&C found indications of bias in various Sustainalytics products.<sup>14</sup> For example, the report reveals pre-existing bias in the GES list of engaged companies. Within the Controversies Research product, the report acknowledged that the most severe controversy ratings were attributed to the Israeli-Palestinian conflict 21 times out of 30—or 70% of the time.<sup>15</sup> The report suggests that this result may be due to a disproportionate amount of media attention. But simply equating reputational risk to how, and the frequency with which, an event is covered by the media—including biased media sources—invariably leads to higher risk scoring for companies that do business in Israel and are thus the subject of advocacy and divestment campaigns. Perversely, such methodology punishes a democracy like Israel with its vibrant and uncensored press and NGO community, subjecting it inappropriately to higher ESG scrutiny.
- 3. Seek the assistance of experts, such as the signatories to this letter, in removing inappropriate language about Israel. W&C identifies as a problem HRR's inflammatory language and statements that gave rise to the perception of "an evaluative judgment made with confirmation bias." But the W&C report merely recommends highlighting such bias for customers and investment managers. That solution inappropriately places the burden on those who are using this ratings product, many of whom rely without further inquiry on the reliability of such reports and leaves unresolved the core problem that biased language colors the ratings.
- 4. Establish systems and implement trainings to ensure Sustainalytics officers and employees are better educated on the issues and able to identify and avoid anti-Israel bias in sources and terminology. The W&C report reveals recurring, troubling instances of insufficiently controlling for anti-Israel bias among employees who analyze Israel-related companies. Morningstar should engage reputable organizations and use reputable sources to train Sustainalytics personnel on antisemitism, including contemporary manifestations of antisemitism, such as demonization of Israel and application of double-standards to Israel. The company should establish systems to ensure that persons responsible for analyzing and rating companies doing business in or with Israel receive the training and oversight to ensure that bias in choices of sources, terminology or other aspects of their work do not continue.

5. Avoid overly broad categorization of business activities that indiscriminately capture and brand run-of-the-mill companies as controversial.<sup>17</sup> Sustainalytics places companies on a "watchlist" or claims they are "noncompliant" when they are engaged in a broad category of activity such as "security for the checkpoints or walls," even though this category also captures equipment used for Israeli residents' security. Such simplistic categorization effectively denies Israel's right and responsibility to protect its own people, including its Arab citizens and residents, its American visitors, and newly arrived refugees from countries like Ukraine and Sudan.<sup>20</sup>

Again, we appreciate the initial steps that you have committed to taking to remove some of the anti-Israel bias from Sustainalytics and your willingness to engage with stakeholders. In that spirit, we urge you to complete the work you began with the W&C investigation by addressing the additional issues highlighted above, which would ensure that you do not provide a foundation for the BDS campaign by discriminating against Israel and damaging Israeli companies and those doing business with Israel. We would be glad to collaborate with you and the Ombudsperson in further work to rectify these issues.
