On June 17, 2016, BATS Exchange, Inc. (the "Exchange") filed with the Securities and Exchange Commission (the "Commission") Amendment No. 3 to SR-BATS-2016-16, a partial amendment which clarified certain components of the Amendment No. 1 to SR-BATS-2016-16, which was submitted on April 8, 2016, and was partially amended by Amendment No. 2, which was submitted on April 14, 2016, and amended and replaced in its entirety the original proposal, which was filed on March 7, 2016. The Exchange submitted proposal SR-BATS-2016-16 in order to list and trade shares of the Pointbreak Diversified Commodity Strategy Fund of the Pointbreak ETF Trust under BATS Rule 14.11(i) and Amendment No. 3 in particular was filed in order to clarify certain points and add additional details to the proposal. In order to provide notice for public review of this Amendment No. 3, in addition to posting on the Exchange's public website, the Exchange is filing this comment letter with the Commission.

Partial Amendment No. 3 to SR-BATS-2016-16

BATS Exchange, Inc. (the "Exchange" or "BATS") is filing this Partial

Amendment No. 3 to SR-BATS-2016-16, which was originally submitted on March 7,

2016 and subsequently amended and replaced in its entirety by Amendment No. 1 (the
"Proposal"), which was originally submitted on April 8, 2016, and partially amended by

Amendment No. 2, which was submitted on April 14, 2016. Pursuant to the Proposal, the

Exchange proposed a rule change in order to list and trade shares of the Pointbreak

Diversified Commodity Strategy Fund of the Point Break ETF Trust under BATS Rule

14.11(i). This Partial Amendment No. 3 proposes to make a clarifying change by adding
a paragraph in two places in the Proposal and removing one phrase that appears in two

places in the Proposal, as described below. The Exchange believes that these proposed

changes are clarifying changes that add additional detail to the Proposal, as further

described below, and are consistent with the act in that they would further clarify and add

additional detail to the Proposal and eliminate potential confusion.

The Exchange is proposing to add the following paragraph to the Proposal before the first full paragraph on page 16 of 55 and the after the second full paragraph on page 42 of 55, which reads as follows:

While the Fund's requirement that creation and redemption requests be received no later than 10:30 a.m. Eastern Time on any business day is relatively early in the trading day, such cutoff time provides the Fund as well as authorized participants and market makers with certain advantages. Such cutoff time will provide the Fund with certainty as to whether to buy or sell certain Commodity Futures in advance of their respective settlement times, which should assist in

minimizing the difference between the price used to calculate NAV and the price at which the Fund is able to buy or sell such Commodity Futures, benefitting the Fund and its shareholders. In addition, the early cutoff time will provide authorized participants and market makers with certainty as to the prices that will be used for calculating NAV and that they will be able to transact at those prices, which should assist such authorized participants and market makers to efficiently hedge their position. Further, such cutoff time should not significantly interfere with the arbitrage mechanism because authorized participants and market makers will continue to be able to hedge their positions in the Fund by investing directly in Commodity Futures as trading continues after settlement time. Although market makers and authorized participants that accumulate positions after the cutoff time may take on risk or additional costs to the extent they have to hold part or all of their positions overnight, such risk or additional costs also does not generally interfere with the arbitrage mechanism.

The Exchange is also proposing to delete the following language from the last sentence before the section titled "Principal Holdings" on pages 8 and 34:

"Although the Fund seeks returns comparable to the returns of the Benchmark,".

As noted above, the Exchange believes that the proposed changes represent clarifying changes that add additional detail to the Proposal that is designed to ensure that the language in the Proposal is as clear as possible.
