## **PARTIAL AMENDMENT**

BOX Options Exchange LLC (the "Exchange") submits this Amendment No. 1 (the "Amendment") to rule filing SR-BOX-2015-06 (the "Rule Filing") in which the Exchange proposes to amend its rules for the listing and trading on the Exchange of options settling to the RealVol™ SPY Index ("Index"). The Exchange is not proposing any changes to the Rule Filing except as set forth below.

The purpose of this Amendment is to correct an inaccurate statement regarding the minimum strike price interval range limitations for new series of index options. Specifically, the Exchange proposes to delete (i) the text of Form 19b-4 contained in the last two sentences of the first full paragraph on page 10 of the Rule Filing and (ii) the first two sentences on page 28 of the Exhibit 1 to Form 19b-4 and replace each with the following text and to renumber subsequent footnotes in the Rule Filing accordingly:

"The Exchange proposes that the minimum strike price intervals for VOLS remain subject to these range limitations."

With this, the Exchange also proposes to amend Rule 6090(c)(7) in the Exhibit 5 to Form 19b-4 on page 41 of the Rule Filing by deleting the text in brackets and inserting the underlined text as shown below:

(7) [Notwithstanding Rule 6090(c)(3) and (c)(4), t]The interval between strike prices for options on the RealVol™ SPY Index will be \$0.50 or greater where the strike price is less than \$75, \$1 or greater where the strike price is \$200 or less and \$5 or greater where the strike price is greater than \$200.
