Partial Amendment No. 3 to SR-NASDAQ-2017-029

The NASDAQ Stock Market LLC is filing this Partial Amendment No. 3 to SR-NASDAQ-2017-029 Amendment No. 2, which superseded the original filing in its entirety, to make the following changes to the pending 19b-4 and Exhibit 1:

1. In the second line of the second full paragraph on page 7 of 55 of the 19b-4, as well as in the second line of the second full paragraph on page 33 of 55 of the Exhibit 1, insert the word “primarily” after the word “invests”.

The proposal SR-NASDAQ-2017-029, as amended, remains consistent with the Securities Exchange Act of 1934, and specifically with Section 6(b)(5) because it makes a clarifying change to the filing and does not make any changes that are unique or novel. Partial Amendment 3 specifically clarifies that the Gabelli RBI NextShares Fund invests primarily in equity securities.
