Partial Amendment No. 2 to SR-NASDAQ-2017-033

The NASDAQ Stock Market LLC (“Nasdaq”) is filing this Partial Amendment No. 2 to SR-NASDAQ-2017-033 Amendment No. 1, which superseded the original filing in its entirety, to make the following changes to the pending 19b-4 and Exhibit 1:

1. In the second line of the second full paragraph on page 32 of 80 of the 19b-4, as well as in the second line of the first full paragraph on page 71 of 80 of the Exhibit 1, insert the words “or reference assets” after the words “of the portfolio”.

The proposal SR-NASDAQ-2017-033, as amended, remains consistent with the Securities Exchange Act of 1934, and specifically with Section 6(b)(5) because it makes a clarifying change to the filing and does not make any changes that are unique or novel. Partial Amendment No. 2 specifically clarifies the continued listing representations made in the filing include those that involve the description of the portfolio or reference assets and shall constitute continued listing requirements for listing the shares of the First Trust California Municipal High Income ETF on Nasdaq.
