Partial Amendment No. 2 to SR-NASDAQ-2017-091

The Nasdaq Stock Market LLC (“Nasdaq” or “Exchange”) is filing this Partial Amendment No. 2 to SR-NASDAQ-2017-091 to make the following changes to the pending 19b-4 and Exhibit 1:

1. In the sixth line of the first full paragraph on page 3 of 54 of the 19b-4, as well as in the third line of the second full paragraph on page 28 of 54 of the Exhibit 1, insert the word “Duration” after “Ultra-Short”.
2. In the underlined heading on page 6 of 54 of the 19b-4, as well as in the underlined heading on page 31 of 54 of the Exhibit 1, insert the word “Duration” after “Ultra-Short”.
3. In the title of the Exhibit 1 on page 28 of 54 of the Exhibit 1, insert the word “Duration” after “Ultra-Short”.

The proposal SR-NASDAQ-2017-091, as amended, remains consistent with the Securities Exchange Act of 1934, and specifically with Section 6(b)(5) because it makes a clarifying changes to the filing and does not make any changes that are unique or novel. Partial Amendment No. 2 specifically clarifies that the name of the Fund will be Calvert Ultra-Short Duration Income NextShares.¹

¹ The Exchange is also updating the Fund’s name to the Calvert Ultra-Short Duration Income NextShares in the Form 19b-4’s description field for this amendment.
