This rule should be voted against. Financial Institutions like banks and hedge funds should not be allowed to sell securities that result in Failures-to-Deliver. The SEC should not be allowing rules changes to help facilitate more Failures-to-Deliver. This rule would allow the laundering of illegal naked shorts and number of mounting FTDs.
