SR-NYSEArca-2018-55- Partial Amendment No. 1

NYSE Arca, Inc. (the “Exchange”) hereby amends SR-NYSEArca-2018-55 (the “Filing”) as follows:

1. The Exchange proposes to add the following after the second full paragraph on page 7 of the Filing and after the first paragraph on page 22 of Exhibit 1 of the Filing:

“Although the Trust will not invest in gold futures, information about the gold futures market is relevant as such markets contribute to, and provide evidence of, the liquidity of the overall market for gold.”

2. The Exchange proposes to add the following after the second sentence of the second full paragraph on page 7 of the Filing and after the second paragraph on page 22 of Exhibit 1 of the Filing:

“The CME Group and ICE are members of the Intermarket Surveillance Group.”

All other representations in the Filing remain unchanged as stated therein and no other changes are being made.
