SR-NYSEArca-2018-57-Partial Amendment 3

NYSE Arca, Inc. (the “Exchange”) hereby amends Amendment 2 to SR-NYSEArca-2018-57 (the “Filing”) as follows:

1. The seventh sentence of the second full paragraph on page 12 of the Filing and the second full sentence of the first partial paragraph on page 32 of Exhibit 1 to the Filing are deleted and are replaced with the following:

“Price information on U.S. Treasury securities and cash equivalents is available from major broker-dealer firms or market data vendors, as well as from automated quotation systems, published or other public sources, or online information services.”

2. The last sentence of the second full paragraph on page 15 of the Filing and the last sentence of the first full paragraph on page 36 of Exhibit 1 to the Filing are deleted and are replaced with the following:

“Price information on U.S. Treasury securities and cash equivalents is available from major broker-dealer firms or market data vendors, as well as from automated quotation systems, published or other public sources, or online information services.”

3. The words “Adviser’s website” in the third full sentence on page 11 of the Filing and the fifth sentence of the first full paragraph on page 29 of Exhibit 1 to the Filing, and the words “Trust’s website” in the first sentence in the third full paragraph on page 11 of the Filing and the first sentence of the second full paragraph on page 30 of Exhibit 1 to the Filing, are replaced with the words “Fund’s website”.
4. The words “the Trust will disclose on its website” in the first sentence of the bottom partial paragraph on page 11 of the Filing, and the first sentence of the bottom partial paragraph on page 30 of Exhibit 1 to the Filing are replaced with the words “the Fund will disclose on its website”.

All other representations in the Filing remain unchanged as stated therein and no other changes are being made.
