NYSE Arca, Inc. (the "Exchange") hereby amends Amendment 4 to SR-NYSEArca-2018-57 (the "Filing") as follows:

1. The last partial sentence on page 4 of the Filing carrying over to page 5 and the last full sentence on page 20 of Exhibit 1 to the Filing are deleted and are replaced with the following:

"The "Index Provider" ("S-Network Global Networks, Inc.") is not registered as an investment adviser or as a broker-dealer and is not affiliated with an investment adviser or a broker-dealer."

2. The first sentence of the fourth full paragraph on page 14 of the Filing and the first sentence of the first full paragraph on page 35 of Exhibit 1 to the Filing are deleted and are replaced with the following:

"The Index Provider is not registered as an investment adviser or as a brokerdealer and is not affiliated with an investment adviser or a broker-dealer."

3. The fourth sentence of the first full paragraph on page 11 of the Filing and the fourth full sentence on page 32 of Exhibit 1 to the Filing are deleted and replaced with the following:

"Price information on U.S. Treasury securities and cash equivalents is available from major broker-dealer firms or market data vendors, as well as from automated quotation systems, published or other public sources, or online information services."

4. The sixth sentence of the second full paragraph on page 15 of the Filing and the sixth sentence of the second full paragraph on page 36 of Exhibit 1 to the Filing are deleted and replaced with the following:

"Such price information on U.S. Treasury securities and cash equivalents is available from major broker-dealer firms or market data vendors, as well as from automated quotation systems, published or other public sources, or online information services."

All other representations in the Filing remain unchanged as stated therein and no other changes are being made.
