ORDER APPOINTING DISTRIBUTION AGENT

The Court, having reviewed the Motion and Memorandum of Plaintiff Securities and Exchange Commission (the "SEC") to appoint Analytics Consulting LLC ("Analytics") as Distribution Agent for the funds collected and to be collected in this matter, plus accrued interest (the "Distribution Fund"), and for good cause shown,

IT IS HEREBY ORDERED:

- 1. The Motion is **GRANTED**;
- 2. Analytics is appointed to serve as the distribution agent of the Distribution Fund in this matter, pursuant to the terms of a distribution plan to be approved by this Court. Analytics shall coordinate with the Court-appointed Tax Administrator to ensure that the Distribution Fund, a Qualified Settlement Fund ("QSF") under Section 468B(g) of the Internal Revenue Code, and related regulations, 26 C.F. R. §§ 1.468B-1 through 5, complies with all related legal and regulatory requirements,

including but not limited to, satisfying any reporting or withholding requirements

imposed on distributions from the QSF.

3. Analytics shall invoice all administrative fees and expenses incurred in the

administration and distribution of the Distribution Fund to the SEC staff for review

and approval for payment from the Distribution Fund. Any unresolved objections

to an invoiced amount will be referred to the Court.

4. Once a distribution plan is approved, Analytics will submit quarterly progress

reports to the SEC staff. Upon completion of Analytics' duties as Distribution

Agent, Analytics shall provide a final report acceptable to the SEC staff; and a final

accounting report for the Distribution Fund in a format to be provided by, and

substantively acceptable to, the SEC staff. The SEC staff shall file the final

accounting report for the Distribution Fund with the Court.

5. Analytics may be removed sua sponte at any time by the Court or upon motion of

the SEC and replaced with a successor. In the event Analytics decides to resign, it

will first give written notice to the Court and to SEC staff of such intention, and the

resignation, if permitted, will not be effective until the Court appoints a successor.

IT IS SO ORDERED.
