**LAST DAY TO FILE CLAIM ("BAR DATE"): MAY 31, 2009**

Dear Investors:

Claim Process:

The Securities and Exchange Commission ("SEC") has identified you as a possible investor in foreign currency options purchased through one of the above named persons. The U.S. District Court has entered a Judgment against CTI and the named individuals, (collectively, "CTI"). There are funds potentially available for recovery of a portion of your investment losses caused by and through CTI, pursuant to the Court's restitution program.

The Court entered an Order Appointing Distribution Agent that sets forth a claim(s) procedure for presenting your principal investment claim against CTI and the other persons listed above. A Proof of Claim form and a Notice of Last Day To File Proof of Claim are enclosed. To effectively file your claim, you must deliver to the Distribution Agent a fully completed and originally signed Proof of Claim. To ensure its timely filing, it is

recommended that you send the Proof of Claim form and all supporting documents by certified mail, return receipt requested, as soon as possible.

The Proof of Claim form must include a completed "Supplemental Claim Form" (which is enclosed) and copies of your payment documentation supporting the claim, particularly canceled checks, wire transfer receipts, brokerage account statements, etc. The Court will make the final determination of the approved amount of your claim.

#### Time Limit to File Claim

You must execute and mail to my office a completed and duly signed Proof of Claim by MAY 31, 2009, or 180 days following the first publication on the SEC's internet website ([www.sec.gov](http://www.sec.gov)) of the Notice of Last Day to File Proof of Claim, whichever is later, or your claim may be denied by the Court. If denied, you will not participate in any distribution.

Return the completed original Proof of Claim form, duly signed by all the persons who made and/or participated in the subject investment with the required documents. A **Social Security Number or Federal Identification Number** is required for each Claimant and is an absolute condition to a distribution.

If there is a deceased claimant, please enclose a copy of a Probate Order or Judgment of Distribution or Trust Agreement showing your entitlement to the decedent's share of the proceeds. If the investment was held in joint tenancy, please send a copy of a certified copy of a Certificate of Death and a copy of a recorded Affidavit of Death of Joint Tenant to support your entitlement. You may be asked hereafter to execute an Affidavit of Death of Joint Tenant, if one has not already been executed and recorded in your jurisdiction.
