## NOTICE OF FILING VOLUNTARY DISMISSAL WITH PREJUDICE

PLEASE TAKE NOTICE that Plaintiff Securities and Exchange Commission ("SEC"), pursuant to Rule 41(a), Federal Rule of Civil Procedure, hereby files this Notice of Filing Voluntary Dismissal With Prejudice as to the SEC's remaining claims in this matter, specifically, the SEC's claims for disgorgement and civil penalties against Defendants Families On Line Corporation ("FOL"), Mark C. Thurman and Robert D. Fiene.

FOL, Thurman and Fiene have been permanently enjoined by this Court pursuant to Judgments entered by their consents, which Judgments provided for disgorgement and civil penalties. However, FOL is defunct and its assets are under the control of the Court-appointed Receiver. Defendants Thurman and Fiene have been criminally convicted in a parallel criminal proceeding, are incarcerated and have been ordered to pay restitution in the amounts of \$4.1 million and over \$3.4 million, respectively. Accordingly, the SEC hereby voluntarily dismisses



its remaining monetary claims against FOL, Thurman and Fiene, and advises this Court that the SEC has no further pending issues in this case, and the only remaining issues in this matter pertain to the receivership over FOL and distribution of its limited assets to investors.
