# ORDER *GRANTING* PLAINTIFF SECURITIES AND EXCHANGE COMMISSION'S MOTION TO SET A CIVIL PENALTY AGAINST DEFENDANT ROBERT WILDER

THIS CAUSE comes before the Court upon the Plaintiff Securities and Exchange Commission's ("SEC") Motion to Set a Civil Penalty Against Robert Wilder. ("Motion for a Penalty"). On March 30, 2005, a default judgment of permanent injunction was entered against Wilder, which enjoined him from violating Section 10(b) of the Exchange Act, and Rule 10b-5 thereunder. [DE 35]. The Court also retained jurisdiction to set a civil money penalty. The Court has considered the Motion for a Penalty and record herein and being fully advised in the premises, accordingly:

IT IS HEREBY ORDERED AND ADJUDGED that the Motion for a Penalty is GRANTED.

IT IS FURTHER ORDERED AND ADJUDGED that pursuant to Section 21(d)(3) of the Securities Exchange Act of 1934 ("Exchange Act") and based upon the undisputed factual evidence in the record, Defendant Robert Wilder is hereby ordered to pay a civil penalty in the amount of  $\frac{100000}{2000}$ 



## IT IS FURTHER ORDERED, ADJUDGED AND DECREED that Defendant Robert

Wilder shall pay the civil money penalty ordered herein within thirty (30) days after the entry of this Order by sending a money order, certified check, bank cashier's check or bank money order payable to the U.S. Securities and Exchange Commission, and transmitted to the Office of Financial Management, U.S. Securities and Exchange Commission, 6432 General Green Way, Stop 0-3, Alexandria, VA 22312, under cover of a letter that identifies the Defendant, the caption and case number of this action and the name of this Court. Copies of such check and accompanying cover letter shall be simultaneously transmitted to Christopher E. Martin, Senior Trial Counsel, U.S. Securities and Exchange Commission, Southeast Regional Office, 801 Brickell Avenue, Suite 1800, Miami, Florida 33131.
