FINAL JUDGMENT AS TO DEFENDANT DEMETRIS B. BROWN

The Securities and Exchange Commission having filed a Complaint and Defendant Demetris D. Brown ("Defendant"), having entered a general appearance; consented to the Court's jurisdiction over Defendant and the subject matter of this action; consented to entry of this Final Judgment without admitting or denying the allegations of the Complaint (except as to jurisdiction); waived findings of fact and conclusions of law; and waived any right to appeal from this Final Judgment:

1.

IT IS HEREBY ORDERED, ADJUDGED, AND DECREED that Defendant and Defendant's agents, servants, employees, attorneys, and all persons in active concert or participation with them who receive actual notice of this Final Judgment by personal service or otherwise are permanently restrained and enjoined from aiding and abetting any violation of Section 13(a) of the Securities Exchange Act of 1934 ("Exchange Act") [15 U.S.C. § 78m(a)], and Rules 13a-1, 13a-13, and 12b-20, thereunder [17 C.F.R. §§ 240.13a-1, 240.13a-13, and

240.12b-20], by knowingly providing substantial assistance to an issuer in violating federal securities laws requiring it to file with the Commission accurate periodic reports.

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that Defendant shall pay a civil penalty in the amount of \$15,000 pursuant to Section 21(d)(3) of the Exchange Act [15] U.S.C. § 78u(d)]. Defendant shall make this payment within thirty (30) business days after entry of this Final Judgment by certified check, bank eashier's check, or United States postal money order payable to the Securities and Exchange Commission. The payment shall be delivered or mailed to the Office of Financial Management, Securities and Exchange Commission,

Operations Center, 6432 General Green Way, Mail Stop 0-3, Alexandria, Virginia 22312, and shall be accompanied by a letter identifying Demetris B. Brown as a defendant in this action; setting forth the title and civil action number of this action and the name of this Court; and specifying that payment is made pursuant to this Final Judgment. A copy of this letter, together with a copy of the check or money order, shall be sent to the attention of Elaine C. Greenberg,

Associate Regional Director, Securities and Exchange Commission, 701 Market Street, Suite 2000, Philadelphia, PA 19106. Defendant shall pay post-judgment interest on any delinquent amounts pursuant to 28 U.S.C. § 1961. The Commission shall remit the funds paid pursuant to this paragraph to the United States Treasury.

There being no just reason for delay, pursuant to Rule 54(b) of the Federal Rules of Civil Procedure, the Clerk is ordered to enter this Final Judgment forthwith and without further notice.
