Pursuant to settlements, the Commission also is contemporaneously filing Consents by Defendants Nicholas Bachynsky and Richard Anders to Final Judgments, which, among other things, enter injunctive relief for the Commission and dismiss its monetary claims, thereby concluding the Commission's case against Bachynsky and Anders. Because this voluntary dismissal also eliminates the Commission's claims for monetary relief against Defendants Laurence Dean and Helvetia Pharmaceuticals, Inc., the only remaining matters to litigate in this case are the Commission's pending Motion for Summary Judgment against Dean (D.E. 83) and its Motion for Default Judgment against Helvetia (D.E. 86). Dean and Helvetia have failed to respond to these motions, which the Commission believes the Court may now enter by default.
