FINAL JUDGMENT AS TO DEFENDANT ANTHONY C. SUDOL, III

The Securities and Exchange Commission having filed a Complaint and Defendant Anthony Sudol having entered a general appearance; consented to the Court's jurisdiction over Defendant and the subject matter of this action; consented to entry of this Final Judgment without admitting or denying the allegations of the Complaint (except as to jurisdiction); waived findings of fact and conclusions of law; and waived any right to appeal from this Final Judgment:

I.

IT IS HEREBY ORDERED, ADJUDGED, AND DECREED that Defendant and Defendant's agents, servants, employees, attorneys, and all persons in active concert or participation with them who receive actual notice of this Final Judgment by personal service or otherwise are permanently restrained and enjoined from violating, directly or indirectly, Section 10(b) of the Securities Exchange Act of 1934 (the "Exchange Act") [15 U.S.C. § 78j(b)] and Rule 10b-5 promulgated thereunder [17 C.F.R. § 240.10b-5], by using any means or instrumentality of interstate commerce, or of the mails, or of any facility of any national securities exchange, in connection with the purchase or sale of any security:

- (a) to employ any device, scheme, or artifice to defraud;
- (b) to make any untrue statement of a material fact or to omit to state a material fact necessary in order to make the statements made, in the light of the circumstances under which they were made, not misleading; or
- (c) to engage in any act, practice, or course of business which operates or would operate as a fraud or deceit upon any person.

II.

IT IS HEREBY FURTHER ORDERED, ADJUDGED, AND DECREED that Defendant is liable for a penalty in the amount of \$289,507. Based on Defendant's sworn representations in his Statement of Financial Condition dated October 4, 2005, and other documents and information submitted to the Commission, however, the Court is ordering Defendant to pay a civil penalty in the amount of \$150,000, as set forth below in Paragraph III. The determination to waive payment of all but \$150,000 of the penalty is contingent upon the accuracy and completeness of Defendant's Statement of Financial Condition. If at any time following the entry of this Final Judgment the Commission obtains information indicating that Defendant's representations to the Commission concerning his assets, income, liabilities, or net worth were fraudulent, misleading, inaccurate, or incomplete in any material respect as of the time such representations were made, the Commission may, at its sole discretion and without prior notice to Defendant, petition the Court for an order requiring Defendant to pay the maximum civil penalty allowable under the law. In connection with any such petition, the only issue shall be whether the financial information provided by Defendant was fraudulent, misleading, inaccurate, or incomplete in any material respect as of the time such representations were made. In its petition, the Commission may move this Court to consider all available remedies, including, but not limited to, ordering Defendant to pay funds or assets, directing the forfeiture of any assets, or sanctions for contempt of this Final Judgment. The Commission may also request additional discovery. Defendant may not, by way of defense to such petition: (1) challenge the validity of the Consent or this Final Judgment; (2) contest the allegations in the Complaint filed by the Commission; (3) assert that payment of disgorgement, pre-judgment and post-judgment interest

1 or a civil penalty should not be ordered; (4) contest the amount of disgorgement and pre-
2 judgment and post-judgment interest; (5) contest the imposition of the maximum civil penalty
3 allowable under the law; or (6) assert any defense to liability or remedy, including, but not
4 limited to, any statute of limitations defense.

5 III.

6 IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that Defendant
7 shall pay a civil penalty in the amount of \$150,000 pursuant to Section 21A of the
8 Exchange Act [15 U.S.C. § 78u-1]. Defendant shall make this payment within ten (10) business
9 days after entry of this Final Judgment by certified check, bank cashier's check, or United States
10 postal money order payable to the Securities and Exchange Commission. The payment shall be
11 delivered or mailed to the Office of Financial Management, Securities and Exchange
12 Commission, Operations Center, 6432 General Green Way, Mail Stop 0-3, Alexandria, Virginia
13 22312, and shall be accompanied by a letter identifying Anthony Sudol as a defendant in this
14 action; setting forth the title and civil action number of this action and the name of this Court;
15 and specifying that payment is made pursuant to this Final Judgment. Defendant shall pay post-
16 judgment interest on any delinquent amounts pursuant to 28 USC § 1961.

17 IV.

18 IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that the Consent is
19 incorporated herein with the same force and effect as if fully set forth herein, and that Defendant
20 shall comply with all of the undertakings and agreements set forth therein.

21 V.

22 IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that this Court shall retain
23 jurisdiction of this matter for the purposes of enforcing the terms of this Final Judgment.
