IX. 5 IT IS HEREBY FURTHER ORDERED, ADJUDGED, AND DECREED that 6 Defendant is liable for disgorgement of \$25,200.00, representing profits gained as a 7 result of the conduct alleged in the Complaint, together with prejudgment interest thereon 8 in the amount of \$8286.26. Defendant shall satisfy this obligation by paying \$33,486.26 9 within 30 days after entry of this Final Judgment by certified check, bank cashier's check, 10 or United States postal money order payable to the Securities and Exchange Commission. 11 The payment shall be delivered or mailed to the Office of Financial Management, 12 Securities and Exchange Commission, 100 F Street, NE, Stop 6042, Washington DC 13 20549, and shall be accompanied by a letter identifying Edward O'Brien as a defendant 14 in this action; setting forth the title and civil action number of this action and the name of 15 this Court; and specifying that payment is made pursuant to this Final Judgment. 16 Defendant shall pay post-judgment interest on any delinquent amounts pursuant to 28 17 USC § 1961. The Commission shall remit the funds paid pursuant to this paragraph to 18 the United States Treasury. Х. 19 IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that the Consent is 20 21 incorporated herein with the same force and effect as if fully set forth herein. 22 XI. 23 IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that this Court 24 shall retain jurisdiction of this matter for the purposes of enforcing the terms of this 25 Judgment.
